**Sub.: Temporary approval of affiliation of School of Law,  
Sharda University, Greater Noida for 5 year BA.LLB,  
B.Com. LLB & BBA. LLB law courses.**

Sir,

Legal Education Committee at its meeting held on 3<sup>rd</sup> March, 2012 considered the inspection report of the above mentioned college and Committee made the following recommendations:-

Committee considered the inspection report of School of Law, Sharda University, Greater Noida, U. P., submitted by the inspection team of the Bar Council of India. After consideration, the Committee granted temporary approval of affiliation to the aforesaid college for imparting 5 year integrated course i.e. B. A. LL.B., B. Com. LL.B. and B. B. A. LL.B. courses with intake of two sections of 60 students in each section and in each stream for a period of two academic years i.e. for the academic session 2012-2013 and 2013-2014 subject to compliance of the following conditions:-

1. That the institution should appoint two more persons with post graduation / masters' degree. We found that at Sl. No.6 Ms. Reema Sharad and Sl. No.20 Dr. Hemant Kumar Jha are not post graduates; accordingly, appointment should be made in their place for teaching 5 years LLB course. The minimum requirement is a masters' degree. Accordingly, subject to the appointment of two qualified faculty, the approval is granted. Appointment should be made within 2 months and the compliance affidavit be sent to the Bar Council of India. No admission of students be made unless this appointment is made within the said period.
2. Law faculties are mostly constituted by retired persons. The law school should appoint young faculties also.
3. Library is to be improved., College should facilitate E-library to the students.
4. Moot Court Hall is very small. Facility for disable students may be installed.

Compliance of the above conditions be submitted to the Bar Council of India by way of an affidavit within a period of three months.

The above recommendations were considered by the Bar Council of India at its meeting held on 15<sup>th</sup> April, 2012 and accepted the same.


The college shall also comply with the following Rule of the Bar Council of India (Clause (iii) and Explanation 2 of Schedule IV in Part IV of new rules of the Bar Council of India):-

***"Whenever approval of affiliation is granted to the Centres of Legal Education, it shall be necessary for the Centres of Legal Education to deposit Rupees Two Lakh in shape of guarantee to fulfil all the norms of the Bar Council of India. The same shall be liable to be forfeited if norms are not complied with and same shall carry no interest."***

The approval of affiliation now granted by the Bar Council of India is subject to the payment of guarantee amount as mentioned in the above rule.

College authorities are also required to apply to the Bar Council of India for further extension of approval of affiliation six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India i.e. on or before 31<sup>st</sup> December, 2013.
