Item No. 03-03-23/24: Institutionalizing the Quality Assurance Strategies

Establishment of Sharda Student Service Cell Committee.

It was apprised that students face lot of difficulties in documentation work during the exit from the University including issuance of transcripts, marksheets, and in getting no dues clearance. The CoE proposed E-governance of the related processes. The agenda of Establishment of Sharda Student Service Cell Committee was well received by the members. The CoE proposed an ERP to streamline student support services during the exit from the university.

Item No. 03-04-23/24: Review of the Quality of Teaching-Learning Process

Appointment of Academic Managers for checking quality of Teaching & Learning.

The Director-Teaching Learning Centre informed the members that recruitment of academic managers for checking quality of Teaching & learning is in process. This is being done for effective strategic planning, Staff management and policy implementation. These academic managers will have expertise in Teaching Learning process and hence will ensure both academic excellence and student success.

Item No. 03-05-23/24: Review of the Structure & Methodologies of Operations

a. Development of in-house academic portal.

The Dean Academic Office proposed the development of in-house attendance portal E-zone. The e-governance of attendance, faculty, question bank was outsourced by an external agency Rapyder Cloud Solutions Pvt. Ltd.(I-cloud) and was facing lot of issues. The University team proposed to integrate their student & faculty data, question bank, and e zone for smooth conduct of academic processes and in order to have our own in-house portal.

b. Reconstitution of Equal Opportunity Cell

The agenda was well received by the committee members. Reconstitution of Equal Opportunity Cell is in accordance with guidelines issued by UGC to ensure equity and equal opportunity to the community at large in the University. This will enhance the diversity among the students, teaching and non-teaching staff population and at the same time eliminate the perception of discrimination.
