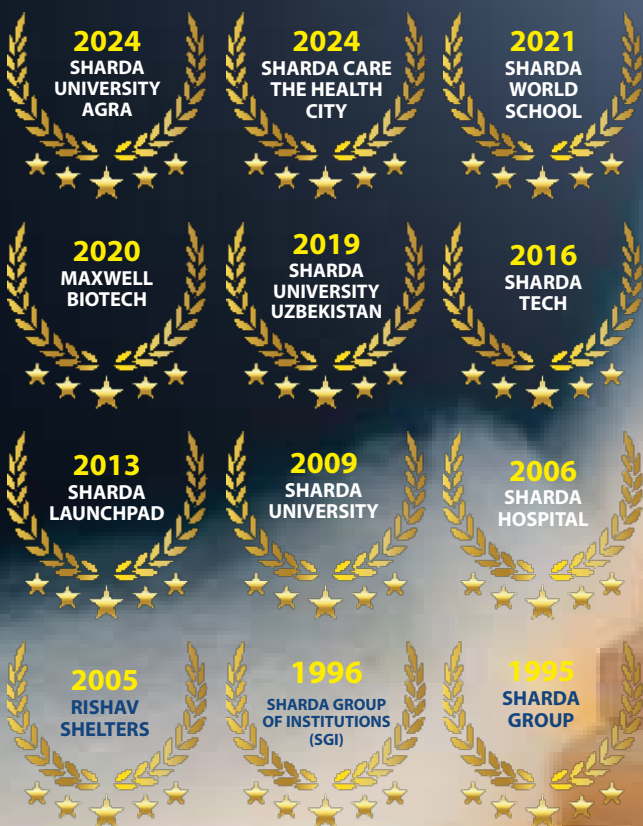

The Mediation team consists of experts Law Faculty, Psychiatrists, Researchers, Clinical Counsellors, NGOs and Police Officials. FDRC has resolved 400+ Family Dispute with 90% success rate.

Regular Free Legal Aid Camps and Community Connect Programme:

Sharda School of Law in collaboration with the District Legal Services Authority, on regular basis, organizes free legal aid camps and community connect programme in Prisons, Courts, Old Age Homes, Primary Schools and other neighbourhood areas where Faculty and Students hold interactive sessions on socio-legal issues.





FAMILY DISPUTE RESOLUTION CLINIC

Knowledge Park, Police Station, Gautam Buddha Nagar
(A Joint Initiative of Sharda University and Gautam Buddha Nagar Police)

Family dispute resolution clinic (FDRC) is a unique initiative started by Gautam Buddha Nagar Police under the dynamic leadership of the Commissioner of Police, Gautam Buddha Nagar, Mrs. Laxmi Singh, IPS. In collaboration with Sharda University, under the visionary leadership of the Hon'ble Chancellor, Mr. P.K. Gupta, Sharda University. The Family Dispute Resolution Clinic was established on July 10, 2020.

Nowadays, belief in marriage as a life-long bond for several lives has changed; even its significance within society has changed drastically. As a result, police stations are flooded with marital dispute complaints. The surge of complaints has raised the need for an alternative, more effective, quick, and speedy mechanism to address this problem. A family dispute resolution clinic facilitates mediation between parties. Mediation is one of the concepts that is very deeply rooted in our Indian culture of dispute resolution. The roots of mediation can be traced way back to the ancient Indian legal systems; for example, the concept of "Shantidoot" before any war or battle was very prevalent in ancient India. If we talk about the recent past, then the system known as the "Gram Panchayats" and "Nyaya Panchayats" was popular and widely practiced in ancient rural India. Mediation is a dynamically structured voluntary dispute resolution process where a neutral third party helps the disputing parties resolve the conflict between them by using specialized communication and negotiation techniques.

To assign responsibilities and role play, a memorandum of understanding (MOU) was renewed under the sign and seal of DCP women and child safety Preeti Yadav, Gautam Buddha Nagar, on behalf of the U.P. Police, and between Prof. Komal Vig, Dean, School of Law, Sharda University, on July 10, 2023.

A team consisting of different domain experts in the field of dispute resolution, headed by mediation expert and senior counsellor Dr. Ritu Gautam, Assistant Professor of Law, has been constituted. The team includes Dr. Avinash Krishna Goswami (Law expert), Dr. Kiran Sharma (mental health expert), Ms. Bhawna Upadhyay (psychiatric social worker), Ms. Archana Dhanakar (Clinical psychiatry), Dr. Ruchi Gautam (psychologist), Dr. Sanchita Ray (political Science expert),

This team dedicatedly provides counselling every Friday and Saturday and even the outbreak of the pandemic COVID-19 couldn't deter the team from performing their duties efficiently. The Family Dispute Resolution Clinic has become the talk of the town by setting a never-before-before example with an 87.81% success rate in resolving family disputes over the past three and a half years. The efforts of the FDRC team have been appreciated on different platforms.

In last three and half year, more than app. 4200 counseling sessions were conducted by the team at Family Dispute resolution clinic to address 1088 cases. In only 118 cases the parties couldn't reconcile their differences and FIR had to be lodged. FDRC has achieved commendable successes rate of 85% in 2023 and 87.81% overall in last three and half years. Primary objective of Family dispute resolution clinic is to reconcile between husband and wife and leads them to find out a amicable solution to the problem. There were cases where cross complaints were filed, multiple FIR filed in the same matter, Primary objective is to get divorce but unnecessary criminal charges framed against each other. Counselors help the parties to identify real issues between them, suggest effective solution, guide them the right path, psychologically counsel them and help parties to reach to an mutually agreeably and appreciate solution.
