

In continuation of this Ministry's letter of even number dated 30.3.2013, I am directed to convey the approval of Central Government for renewal of permission for 3<sup>rd</sup> year MDS course in the specialities of (i) Periodontology with 3 seats (ii) Oral & Maxillofacial Surgery with 3 seats (iii) Prosthodontics and Crown & Bridge with 3 seats (iv) Oral Pathology & Microbiology with 3 seats (v) Orthodontics & Dentofacial Orthopedics with 3 seats (vi) Conservative Dentistry and Endodontics with 3 seats (vii) Paedodontics and Preventive Dentistry with 3 seats at School of Dental Sciences, Greater Noida for the academic year 2014-15.

2. The admission of next batch of students in MDS Course in the above specialities for the academic year 2015-16 will be made only after recognition of MDS Degree by the Central Government.
3. In case any admissions are made in violation of this condition, such admissions would be treated as irregular and action under 10B of the Dentists (Amendment) Act, 1993 would be initiated.
4. Discrepancies, if any, may be brought to the Notice of DCI and State / Central Government.


